Probable Cause Affidavit

Before me this date personally appeared MONTERROSA, JUAN (3357) who being first duly sworn deposes and says that on 31 day of December, (year) 2015 at 905 N BROADWALK, HOLLYWOOD, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

UP TO MAKE SURE SHE GOT HOME SAFELY. THE ARRESTEE WAS EXTREMELY BELLIGERENT, CONTINUED TO SHOUT OUT PROFANITY SUCH AS "FUCK YOU."

WHILE TRYING TO GET THE ARRESTEE TO COOPERATE WITH US SHE FINALLY ALLOWED US TO SPEAK WITH HER BOYFRIEND, A BLACK MALE LATER IDENTIFIED AS JASON THEODORE, VIA HER CELL PHONE. IT SHOULD BE NOTED WHILE SPEAKING TO JASON THE ARRESTEE STATED NUMEROUS TIMES THAT THERE WERE SEVEN OFFICERS ON SCENE, WHEN IN FACT IT WAS JUST FOUR OF US. SHE STATED NUMEROUS TIMES THAT SHE HAS A LOT OF FAMILY IN LAW ENFORCEMENT AND WE WOULD BE HEARING FROM THEM. A FEW MINUTES LATER JASON ARRIVED ON SCENE AND THEY STARTED TO WALK SOUTHBOUND ON THE BOARDWALK. WHILE WALKING ON THE BOARDWALK THE ARRESTEE CONTINUED TO SHOUT OUT PROFANITIES AND HAD POOR BALANCE.

THE ARRESTEE AND JASON CAME TO A FINAL STOP AT 905 N BOARDWALK WHERE SHE PICKED HER JUVENILE SON UP AND HELD HIM IN HER ARMS. WHILE HOLDING THE JUVENILE THE ARRESTEE'S BALANCE WAS SO POOR CAUSING HER TO LEAN BACK WHICH COULD HAVE INJURED HER JUVENILE SON. I ADVISED A MUTUAL FRIEND OF THE ARRESTEE AND JASON WHO WAS ON SCENE (LATER IDENTIFIED AS ERIC DUGUE) TO TAKE THE BABY FROM THE ARRESTEE FOR HIS SAFETY. AT THAT TIME THE ARRESTEE BEGAN TO SHOUT PROFANITIES VERY LOUDLY TO WHICH I TOLD HER TO STOP BECAUSE WE WERE IN A PUBLIC PLACE AND A CROWD BEGAN TO GATHER. FEARING FOR THE CHILD'S SAFETY AND THE WELL BEING OF THE ARRESTEE I ASKED DUGUE TO REMOVE THE CHILD FROM THE ARRESTEE. IMMEDIATELY AFTER I ATTEMPTED TO PLACE HANDCUFFS ON HER.

I WAS ABLE TO GET ONE HAND CUFF ON THE ARRESTEE'S LEFT WRIST AT WHICH TIME SHE BEGAN TO RESIST BY PULLING HER BODY AWAY, AND THEN KICKING ME IN THE GROIN. STILL RESISTING ME THE ARRESTEE PUNCHED ME IN THE MIDSECTION OF MY LEFT ARM. NOW HAVING BEEN STRUCK

Before me this date personally appeared MONTERROSA, JUAN (3357) who being first duly sworn deposes and says that on 31 day of December, (year) 2015 at 905 N BROADWALK, HOLLYWOOD, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

TWICE BY THE ARRESTEE AND FEARING FOR MY SAFETY I WAS ABLE TO ESCORT HER TO THE GROUND. I ADVISED THE ARRESTEE TO "STOP RESISTING AND PLACE YOUR HANDS BEHIND YOUR BACK." ONCE ON THE GROUND THE ARRESTEE ATTEMPTED TO GET UP AT WHICH TIME OFC. LAHARA #3247 SECURED HER RIGHT ARM. ONCE BOTH ARMS WERE CUFFED WE ESCORTED THE ARRESTEE TO N SURF RD AND BUCHANNAN ST SO WE COULD PLACE HER IN THE REAR OF A MARKED HOLLYWOOD POLICE DEPARTMENT VEHICLE.

OFC. CZERENDA #2614 WALKER #3115, AND LAHARA #3247 STAYED AT BUCHANAN ST AND SURF RD WITH THE ARRESTEE AT WHICH TIME I WALKED BACK TO 905 N BOARDWALK TO MAKE CONTACT WITH JASON AND RETRIEVE THE ARRESTEE'S DRIVERS LICENSE. WHILE RETRIEVING THE DRIVERS LICENSE I WAS ADVISED THE ARRESTEE KICKED OFC. LAHARA #3247 IN THE RIGHT SHIN WHILE BEING PLACED INTO THE REAR OF OFC. CZERENDA'S MARKED POLICE VEHICLE.

IT SHOULD BE NOTED THE ARRESTEE SUSTAINED A MINOR ABRASION TO HER RIGHT KNEE DURING THE ALTERCATION WHICH HOLLYWOOD FIRE RESCUE #RH31 RESPONDED TO HEADQUARTERS TO TREAT. I ALSO SUSTAINED TWO SMALL CUTS ON MY RIGHT MIDDLE AND RING FINGERS.


