On January 27, 2016, at approximately 1500 hours, while conducting a security check in the attorney interview area of the Main Jail, I observed a male inmate, later identified as Granda, Ysreal W/M 501300684, and a female attorney, later identified as Jessica Mishali David W/F, engaged in what appeared to be sexual intercourse in attorney interview room #5.

I observed inmate Granda standing behind Mrs. David, who was bent over at the waist with her skirt raised to her waist area. The front part of Granda's body was pressed firmly against Mrs. David's buttocks area with one of his hands holding Mrs. David at the upper part of her back and his other hand holding Mrs. David at the lower part of her back. Mrs. David appeared to be looking toward the floor. Because of their close proximity, I did not observe exposed sexual organs.

I immediately opened the door to the interview room, at which time inmate Granda quickly sat in the chair that was behind him. Granda's uniform was baggy and I was unable to determine if any of the buttons were not secured on the uniform and I was not able to observe if Granda's penis was exposed. Mrs. David immediately stood causing her skirt to fall back into position covering her thighs.

I ordered Mrs. David to exit the room, which she complied after she retrieved her belongings (laptop and folder). The interview room door remained open as I escorted Mrs. David from the interview area and instructed her to have a seat in the waiting area. I then returned to the interview room where inmate Granda remained seated and I escorted him to the holding cell in the interview area where he was secured alone.

Sergeant Rickmann, CCN 10902 was notified and responded to the scene. Deputy Rovira, CCN 13954 arrived and escorted Mrs. David to the scanner area where she remained until the arrival of detectives from the Special Victims Unit arrived to interview her. The following is a chronological timeline of events:

- 1505 hours Interview Room #5 established as a crime scene.
- 1510 hours Main Jail Command Staff notified.
- 1548 hours Duty Officer Rappaport 17263 notified.
- 1549 hours Crime Scene Sergeant Mosher 7931 notified.
- 1559 hours Sex Crimes Sergeant Sudman 5254 notified.
- 1710 hours Special Victim Unit Detectives Vadal 4762 and Suter 6395 arrived on post.
- 1712 hours Detectives Vadal and Suter interviewed Attorney Jessica David and subsequently released her from custody.
- 1745 hours Crime Scene advised that they will not be responding.
- 1747 hours Interview Room #5 cleared as a crime scene.
- 1749 hours Inmate Granda interviewed by Detectives Vadal 4762 and Suter 6395.
- 1810 hours Inmate Granda escorted back to 8-Charlie by Deputy Brown 6073 and Deputy Milien 16609 and strip searched.
- 1830 hours Detectives Vadal and Suter off post.
- 1953 hoursMaster Control Deputy Peterson 6182 was notified.
- 2007 hours a shakedown of Inmate Granda's cell 8C1-10 conducted with negative results.
- 2351 hours I.A Lieutenant Corbett #12445 notified and will not be responding.
