  - A. I worked various areas in the detention center. I think my last position was in central intake, booking and processing and incoming arrestees.
    - Q. All with BSO?
- A. Yes.

- 11 A. Yes.
- Q. Now, the last four years, you have been employed as a deputy sheriff with the Broward Sheriff's Office?
- 15 A. Yes.
- Q. So you shifted from the correctional aspect of the job to a deputy sheriff aspect?
- 18 A. Yes.
  - Q. To do that, did you have any training to be able to be allowed to serve as a deputy sheriff and change your position as a corrections officer?
    - A. Yes.
- 23 | Q. What did you do?
  - A. I had to take a cross-certification class.
- Q. What does that mean?

- A. I basically had to cover the blocks that they don't cover in the detention academy that's only for the law enforcement academy.
- Q. Did you have any training when you did that with regards to the use of force? Was that before, when you were a corrections deputy?
- A. Yes. We had both in detention and law enforcement.
- Q. And specifically, when you're allowed to use deadly force as a deputy?
  - A. Yes.
  - Q. What was your training in that?
- A. Basically, if our life was in imminent danger, possible death could occur from the incident we're responding to, we're allowed to use deadly force.
- Q. If the life of another person is in danger, do you have any training in regards to that? If it's not just your life, but someone else's?
  - A. Yes.
  - Q. Tell us about the training, please.
- A. Basically, if we're responding to an incident to where either the person is going to be a danger to himself or others around him to the point where there's a possibility for great injury or death, we're allowed to use deadly force.

- Q. Okay. And you received this training when?
- A. I guess in the corrections academy in 2001 and then again in the law enforcement academy in 2009.
- Q. And how is this training received? In other words, you told us there are parameters when you use deadly force, but is it a -- is there any active training in situations or scenarios in the real world?
- A. Yes. We do an in-service training that's conducted every year.
- Q. Tell us about in-service training. What does that mean?
- A. Basically, we go over different scenarios.

  Our last scenario was active shooter. Basically, they are training us now how to deal with I guess areas that have an active shooter in them, how do we approach the situation, how do we enter a building, whether it be a school or courthouse, anywhere where somebody is taking action with a weapon.
- Q. Okay. And what weapon did you carry back on July 31st, 2013? What was your service weapon?
  - A. It was a handgun, a Glock 26, .40 caliber.
  - Q. So it was a .40 caliber pistol?
  - A. Yes.
- Q. And you had -- did you have a -- I assume you had a magazine in the pistol and two extra?

- Q. Okay. Had you, during the course of your training, actually discharged that firearm, practiced with that firearm? Tell us about that.
  - A. We qualify with our weapon every year.
  - Q. What does that mean?
- A. Just to show we're proficient with the weapon, we have to -- we take a practice with the weapon, and then we have to actually do a qualification, which if we don't pass, we're not certified to carry the weapon anymore.
- Q. Did you have any training with regards to what -- similar to what happened in this case as far as a person walking with a potential weapon away from you?
  - A. Yes.
- Q. What were you trained to do in these situations?
- A. Well, these are split second reactions. We've done training before where there's simulations with a movie screen, and they have pellet guns that are pointing at us. Whether we make the right choice or not, whether we are shot in practice.
- I mean, they are not real weapons that we are being shot with, they are more like paintball guns, but they just give us different scenarios on how to approach

them, people walking down the street, people walking away from us, people in the jail that may have obtained a weapon somehow.

Did the orders, verbal orders, the commands that are supposed to be given in situations such as what happened here -- is there any training with regards -not only to giving commands, but what commands are to be given so there's no miscommunications or tragedies that

Do you have any training -- and this is kind of a unique question -- but do you have any training with regards to perhaps when a person is impaired as far as, you know, they can't hear you, if they are deaf, potentially? Is there any kind of sensitivity training in that sense with regards to use of force?
  - A. No.

- Q. July 31st, 2013 was a Wednesday when this happened, this incident, this shooting. How long had you been a deputy away from corrections from that exact day?
  - A. It had been a year and a half.
  - Q. A year and a half?
- A. Yes.
  - Q. When you start off as a deputy, is there a training, in other words, an on-the-job training that you have to go through first?
- A. As soon as we're done with the cross class.
- Q. Yes.
  - A. We're with a field training officer for about three months.
  - Q. And what's the purpose of the field training officer for three months?

- Q. Tell us about your experience. What was the purpose of that? Can you pass? Can you fail?
- 4
- A. Yes, you can. If you fail, they let you go.
- 5
- You are terminated from law enforcement.
- 6
- Q. And the purpose of the FTO is to do what?
- 7
- What do they do with you?
- 8
- A. They train you how to answer calls, daily calls as a road patrol officer.
- 10
- Q. And you do successfully go through those three
- 11
- months, I assume?
- 12
- A. Yes.
- 13
- Q. Do you have any training about, when you do

- have to use force, as to how to shoot or if you would
- 15
- have to fire your weapon when you're aiming at a

- would kind of incapacitate the threat almost immediately.
  - Q. And how long are you supposed to fire when you have a deadly force situation?
    - A. Until there's no longer a threat.
  - Q. So you're taught to fire until the threat stops?
    - A. Yes.
      - Q. Now, July 31st, 2013, were you on duty?
- A. Yes.

- Q. Okay. Were you dressed in a uniform similar to what you are today as far as the BSO patches on the sleeves, the badge on your left chest, the utility belt, etc.?
  - A. Yes.
- Q. The call, based upon what we see from the evidence, came in about 4:10, 4:11 in the afternoon. Where were you right before the call came in?
  - A. I was at our district office.
  - Q. Okay. The Oakland Park district office?
- A. Yes.
  - Q. What were you doing there?
- A. I was waiting for a sergeant.
  - Q. Okay. And what happens?
  - A. I was dispatched to the call. I was available

- for calls. The dispatcher advised there was a

  disturbance with a weapon. There was an individual

  described as a black male wearing a white shirt and blue

  jeans walking north on Dixie Highway on the west side of

  the road.
  - Q. Okay. Did -- were you in the building or were you in the car by the station?
    - A. I was in the building at the time.
  - Q. Okay. So when you say you were dispatched, did you have your radio with you, or you hear the call and then you go to the car?
    - A. Yes.

- Q. Okay. Did you have a marked car?
- 14 A. Yes, I did.
  - Q. All the bells and whistles as far as BSO insignia and all that?
  - A. Yes.
    - Q. Okay. You get in the car. Where do you go?
  - A. I headed south. It's only about maybe -- from where dispatch had stated the individual is walking is maybe four or five blocks. It wasn't very far at all.
    - Q. On Dixie Highway?
- 23 **A.** Yes.
- Q. Okay. As you're going south on Dixie Highway, any updates?

- A. Yes. Other than the disturbance call, then they said they were getting multiple 911 calls, basically other people calling in describing the same situation.
- Q. Okay. And as you're going south on Dixie, what information do you know or do you have in your mind before you actually see the suspect?
- A. I just have to probably approach with caution, just approach with caution, be careful. If there is a person walking around with a firearm, it's possibly loaded. He can see my unit and immediately start to fire.
- Q. What information do you have in your -- what did you hear what the call was about exactly? What did you already know before you had contact visually with Mr. McBean?
- A. That he was walking north on Dixie Highway carrying a rifle.
- Q. Okay. You're going south. You're in the car by yourself?
  - A. Yes.
  - Q. When do you first see Mr. McBean?
- A. I saw him at the 5200 block of North Dixie Highway. He was on the westbound side walking north.
  - Q. So he's in the lane -- the sidewalk closest to

  - A. I believe he saw my vehicle.
    - Q. I understand that. But did he --
    - A. No, he didn't point the weapon at me.
- Q. Why didn't you stop and take cover behind your car while you were in front of him at that point in time?
- A. At that point in time, I mean, it was too close. He was about maybe five feet from my vehicle, so there would have been no cover. It would have been almost an ambush situation if I would have gotten out of my vehicle and he had a loaded rifle.
  - Q. Even behind the engine block?
- A. No. We were too close. It was too close.
  - Q. Okay. So you went past him --
  - A. I drove just a little past him and then I made

- A. No, I didn't continue north. I blocked the northbound traffic.
  - Q. Okay. LaCerra asked you to do that?
- A. I remember him going over the radio. He was saying he was blocking northbound traffic. He might have given the order, but I just remember I stopped the northbound traffic.
- Q. Okay. Did you see any pedestrian going south on the west side of the sidewalk on Dixie and actually pass Mr. McBean?
- A. No.
  - Q. You never saw that?

- 16 Q. Did you hear that over the radio?
  - A. No.
    - Q. Okay. So as of right now, basically you crossed paths with Mr. McBean, as you described, and he never pointed the gun at you; right?
      - A. No.
      - Q. You did a u-turn and you're blocking traffic?
- A. Right.
- 24 Q. Take us through what happens next.
- A. Well, when he was walking north, he had the

barrel of the gun in his right hand. He was almost
walking with it like a cane. As soon as he passed the
vehicle, he seemed to have picked up his pace, started
walking a little faster, and then he threw the weapon

  - A. Yes.
