He has also been assigned the investigation in the homicide of Roderick Sweeting, DOB 12/17/1998 (hereinafter "The Victim" or "victim") which occurred on Tuesday April 5, 2016 at 4:05 pm. This incident is being investigated under Miami Gardens Police Department case #2016-001689.

On April 5, 2016 at some minutes after 4 pm, Miami Gardens Police Department emergency services received a call reporting a shooting at 17602 NW 25 Avenue, the Oaks apartment, Miami, Florida 33056. When the first police units responded, they found the lifeless body of a young man that was later identified as The Victim.

The complex where the crime happened is surrounded by a chain link fence that is about 5 feet high and on the top there is a metal bar. There are only two gates to get in and out of the complex. There is nearby a strip shopping plaza and one of the stores, a tattoo shop, has a security camera that also partially covers some areas of the apartment complex.

Your Affiant reviewed the video taken by the tattoo shop security camera and found that a male, later identified as The Victim, walked eastbound in the apartment complex followed by a second male later identified as S. R, a juvenile. At the same time the video shows that a subject, later identified as Offender 1 was hiding by the mail boxes of the complex. Then, the video shows that S R becomes were agitated and "Offender 1" comes out of the mail box area while two more subjects, identified as Quarmaine McMillan, (hereinafter "Offender 2") and Rachid Jacques (hereinafter "Offender 3"), run towards The Victim. All the three Offenders opened fire. Offender 1 shot at S. R., while Offenders 2 and 3 shot at The Victim.

Then the video shows that after shooting at The Victim and S. R. Offender 1 ran towards the chain link that surrounds the complex. Offenders 2 and 3 ran towards a hallway and an alley of the complex.

Crime Scene Investigators were called and Nancy Torres, Miami Gardens Pol. Depart. #755, was able to recover some latens from the top aluminum panel of the fence, at the South East corner. The latens were developed and compared by latent print examiner Rupert Butcher who concluded that the latens matched the fingerprints of Offender 1. Your Affiant found that the last known address of Offender 1 is 18000 NW 7th Place, Miami Gardens. A Google map search showed that between the crime scene and Offender 1's address there are 2.4 miles.

Nancy Torres also found and impounded at the crime scene 30 casings of calibers .40 .9 mm and .32.

A caliber 40 casing was found outside the fence in the proximity of the area where the latents that match Offender 1 were lifted.

Your Affiant was also informed that Miami Gardens Officer Luis Pacheco, badge 100-302, and first responder was alerted to the presence of four to five black males running along the chain link fence, at least one of them had a firearm in his hands.

On April 7, 2016 Miami Gardens Detective Joseph Zellner, badge 100-222, attended the autopsy performed at the Miami Dade County Medical Examiner by Doctor Emma Lew. Detective Zellner informed Your Affiant that The Victim had 20 gunshots wounds and some of the projectile trajectories indicates that The Victim was shot even when he was defenseless lying on the ground with his spinal cord severed by the bullets.

Doctor Lew's autopsy concluded that the cause of death was multiple gun shot wounds and the manner of death was homicide.

WHEREFORE, for the foregoing reasons, "Your Affiant" requests a warrant for the arrest of Rachid Jacques aka "Roach" with a date of birth of March 8, 2000 for the violation of Florida Statute §782.04 first degree murder of Roderick Sweeting and first degree attempted murder of S.
