On July 17th, 2016 at approximately 1404 hours, I walked into the Sunoco Gas Station, located at 1700 S Douglas Road. As I was attempting to get a drink from the refrigerator area, a black male, wearing a gray shirt with gray pants, walked up to me and asked why we arrested his "boy". I asked the individual who he was referring to, to which he stated, "ya'll got my boy in the back of that car outside the gas station". I advised that he was arrested and couldn't give him any further information. The individual then walked away.

I then proceeded to walk towards the cashier, in order to pay for my drink. The same individual that walked up to me earlier was standing behind the cash register. The individual had the cashier's window closed, so I knocked on it in order to get his attention. The individual looked at me and didn't say anything. I then stated, "Hey can you ring me up, I need to pay for my Gatorade". The individual then stated "No". I asked him what he meant. The individual stated that he wouldn't ring me up, and stated, "you know why". I proceeded to ask him again to ring me up, and the individual again refused.

During the same time, the individual stated, "get out of my way, I need to attend to customers". I looked behind me, and there was a line of about 4 people trying to pay for their items. I moved out of the way, so the customers could pay. After they were done, I again asked to be ringed up, and the individual refused to provide service. Should be noted that I was in full police uniform. I then asked the individual for his name and his manager or boss's name. The individual stated that he doesn't have to give me his name or his boss's name. I asked the individual why he was refusing to ring up a police officer trying to buy a drink, to which he stated, "Because I don't have to, that's why".

The individual was a black male, wearing gray clothing and long dread locks. The individual also did not have a name tag on his clothing. An RMS Search of the owners information was met with negative results.
