COMES NOW the State of Florida, by and through its undersigned State Attorney and files this Discovery Exhibit, Demand for Reciprocal Discovery and Demand for Notice of Alibi pursuant to Fla. R. Crim. P. 3.220 and 3.200 as follows:

P. 3.200 demanding that the defendant furnish the prosecutor with a Notice of Alibi not less than ten (10) days prior to trial, stating the place the defendant claims to have been at the time of the offense and the names and addresses of witnesses he proposes to use to establish that alibi, if such a defense will be relied upon at trial.

DEMAND FOR RECIPROCAL DISCOVERY
