ARRESTED CO-DEFENDANTS

DEFENDANT DID THE FOLLOWING ACT(S) WHICH CONSTITUTE A VIOLATION OF THE LAW (ELEMENTS OF THE CRIME / PROBABLE CAUSE STATEMENT)

ON 11/29/16 WHILE ON PATROL IN THE AREA OF INTERSTATE 75 EASTBOUND NEAR THE TOLL PLAZA, I OBSERVED A BLACK MW TAG # BVC2169 DRIVE PASSED ME WITH WHAT APPEARED TO BE ILLEGALLY TINTED WINDOWS.

I CAUGHT UP TO THE VEHICLE AT APPROXIMATELY THE 96 MILE MARKER TRAVELING EASTBOUND AND ACTIVATED MY EMERGENCY LIGHTS. THE VEHICLE CONTINUED DRIVING FOR APPROXIMATELY ONE MILE BEFORE COMING TO A STOP.

I APPROACHED THE PASSENGER SIDE OF THE VEHICLE AND COULD IMMEDIATELY SMELL THE ODOR OF THE MARIJUANA COMING FROM INSIDE THE VEHICLE. I MADE CONTACT WITH THE SINGLE OCCUPANT OF THE VEHICLE WHO IS ALSO THE REGISTERED OWNER (LEON J. ORR 02-11-1992). I TOLD HIM THE REASON FOR THE TRAFFIC STOP AND ASKED HIM FOR HIS DRIVER'S LICENSE AND PROOF OF INSURANCE.

HE HANDED ME THE INFORMATION I REQUESTED AND TOLD ME HE HAS BEEN PULLED OVER FOR THE WINDOW TINTS ONE WEEK PRIOR AND ISSUED A CITATION, THEN SHOWED ME THE CITATION.

I ASKED HIM TO EXIT THE VEHICLE AND MEET ME IN THE REAR OF HIS CAR, WHEN HE WAS EXITING THE CAR I NOTICED HE WAS TAKING LONG TO WALK TO THE REAR OF THE CAR AND HE WAS ADJUSTING HIS SHORTS WHILE FACING AWAY FROM DEPUTY MEYER #2578. DEPUTY MEYER HAD TO TELL HIM TO WALK TO THE REAR OF THE CAR TO GET OUT OF THE TRAVEL LANE.

ONCE HE WAS IN THE REAR OF THE CAR, DEPUTY MEYER BEGAN PATTING HIM FOR WEAPONS AND WHEN HE ASKED LEON TO SEPARATE HIS LEGS WE NOTICED HE WAS HESITANT, I TOLD HIM HE WAS HESITANT BECAUSE HE HAD MARIJUANA STUFFED IN HIS PANTS AND THAT HE NEEDED TO JUST BE HONEST ABOUT IT, BECAUSE OF HIS NERVOUS BEHAVIOR AND HESITATION TO LISTEN TO AND COOPERATE WITH OUR INSTRUCTIONS HE WAS DETAINED.

WE FINISHED SEARCHING HIS PERSON AND BEGAN SEARCHING THE VEHICLE.

WHEN I SEARCHED THE FRONT PASSENGER SEAT AREA, I LOCATED A GRAY BACKPACK ON THE FRONT PASSENGER SEAT FLOOR BOARD, ONCE I SEARCHED INSIDE THE BACK PACK I LOCATED WHAT APPEARED TO BE THREE GLASS VIALS CONTAINING WHAT APPEARED TO BE MARIJUANA WAX. I ALSO LOCATED A GREEN PLASTIC BOTTLE CONTAINING A RED LIQUID INSIDE, THE LABEL ON THE PLASTIC BOTTLE HAD KUSH SYRUP ON THE FRONT AND ON THE BACK LABEL THE IT STATED THE SUBSTANCE CONTAINED CANNABIS.

ARRESTED CO-DEFENDANTS

DEFENDANT DID THE FOLLOWING ACT(S) WHICH CONSTITUTE A VIOLATION OF THE LAW (ELEMENTS OF THE CRIME / PROBABLE CAUSE STATEMENT)

ON THE FRONT DRIVER'S DOOR MAP POCKET WE ALSO LOCATED AN ADDITIONAL BOTTLE THAT WAS ORANGE IN COLOR BUT THE LABELS CONTAINED THE SAME WRITING.

I THEN MEASURED THE WINDOW TINTS WHICH RESULTED IN A READING OF 3% ON THE FRONT PASSENGER SIDE WINDOW WHICH IS UNDER THE LEGAL LIMIT OF 28% OR HIGHER.

HIS VEHICLE WAS TRANSPORTED BY GEORGE AND SONS AND HE WAS TRANSPORTED TO THE NAPLES JAIL CENTER BY ROOPER MORALES WITH THE FLORIDA HIGHWAY PATROL.

THE LIQUID SUBSTANCE IN THE GREEN BOTTLE WAS NIK TESTED USING A MARIJUANA TEST KIT WHICH RESULTED IN A POSITIVE READING FOR THC.

THE WAX SUBSTANCE WAS ALSO TESTED USING A MARIJUANA NIK KIT AND IT ALSO TESTED POSITIVE.

ALL THE NARCOTICS WERE PLACED INTO EVIDENCE AS WELL AS THE IN-CAR DVD, THE GUN WAS PLACED INTO EVIDENCE OR SAFE KEEPING.

THE TOTAL PACKAGE WEIGHT OF THE MARIJUANA WAS 22.43 GRAMS, THE TOTAL PACKAGED WEIGHT OF THE WAX IS 70.09 GRAMS AND THE TOTAL PACKAGED WEIGHT OF BOTH BOTTLES IS 105.91 AND 100.70.
