On Monday, January 16th, 2017 at approximately 1720 hours, a large group of motorcycle, ATV and dirt bike riders, participating in the "Bikes Up Guns Down" movement was observed travelling into the City of Hollywood from the area of Pembroke Road and South State Road 7. At the location of State Road 7, between Hollywood Boulevard and Pembroke Road, which is located within the jurisdictional limits of the City of Hollywood, Broward County Florida, the above named defendant did commit the violation of reckless driving to wit; operated an off road all-terrain vehicle on State road 7, a paved state roadway, northbound, from the vicinity of Washington St., speeding at approximately 50 mph in a posted 35 mph area. At approximately the 300 block of South state Road 7. The defendant made an unsafe / improper lane change by making a U-turn, through construction barriers, into oncoming southbound traffic, causing southbound motorists to brake to avoid collision. This driving pattern was done with a willful and wanton disregard for the safety of the motoring public, in violation of Florida State statutes. Upon a City of Hollywood fully marked Police car, operated by Sergeant Justin Schweighardt # 3182, attempting to conduct a traffic stop for the aforementioned criminal violation, the defendant committed the violation of fleeing and cluding to wit: accelerated the all-terrain vehicle, failing to stop for the police cars, that were fully marked with agency insignia and had their emergency red/blue lights and siren in continuous operation, and took evasive maneuvers by making a sudden, abrupt, improper, unsafe U-turn, with the intent to avoid being stopped,



detained, and arrested. The defendant continued to flee past the vicinity of 1200 South State Road 7.

Sergeant Schweighardt observed the defendant using a hand held cellular telephone, in a manner conducive with video recording the incident, as it was taking place. Sergeant Schweighardt terminated pursuit of the defendant when a separate motorcyclist, also fleeing the police, was apprehended at the intersection of south State Road 7 and Rodman St.

Due to the defendant apparently video recording the incident and being with a group believed to be part of the "Bikes Up Guns Down" movement, Sergeant Schweighardt began viewing video postings under the hash tag (#bikesupgunsdown). Sergeant Schweighardt located a video on the social media site Instagram, under the username "banshee\_will"

(https://www.instagram.com/p/BPV2r8OA0AL/?taken-by=banshee\_will&hl=en) The video depicts the defendant operating an all-terrain vehicle (ATV) on State Road 7. While viewing the aforesaid video Sergeant Seweighardt observed his issued, marked Hollywood Police vehicle (Chevy Tahoe) with its emergency red and blue lights activated and the siren in continuous use, directly behind the defendant attempting to stop the all-terrain vehicle. The defendant continues to flee and clude the marked Police car until Sergeant Seweighardt's police vehicle can be seen turning off the roadway. The defendant continues to flee and clude police while a Broward Sheriff's Office marked police vehicle continues to attempt to stop the defendant. The video then ends.

The above listed video and uniform resource locator (URL) were provided to Detective Justin Lang # 3257, for further investigation. Detective Lang viewed Instagram postings, which are publicly available, under username "banshee\_will" and observed several images depicting the same person fleeing from sergeant Schweighardt. One posting depicted a motorcycle with a Pennsylvania license plate of "RUB1A" affixed to it

(https://www.instagram.com/p/BLJ\_Cazg7Fq/?taken-by=banshee\_will&hl=en). Detective Lang conducted an NCIC query via OSSI which listed the registered owner as Wilfredo Garcia Jr. with an address of 418 S. Bradford St. Allentown PA 18109. Detective Lang then inputted the aforementioned information into the CLEAR database which revealed a date of birth of 11/08/1989 and a social security number of attached to the name of Wilfredo

Garcia Jr. Detective Lang conducted a query through the OSSI database for the name Wilfredo Garcia Jr., dob: 11/08/1989 for the State of Pennsylvania. OSSI records revealed a Pennsylvania driver's license with a photograph of the same person recorded on the aforementioned video, fleeing from the police.

A photograph of Wilfredo Garcia Jr., dob: 11/08/1989 was also obtained through The State of Pennsylvania Justice Network (JNET) which listed a photograph of the defendant from a previous arrest. The photograph is the same person observed in the Instagram video fleeing from Sergeant Schweighardt.

A photo lineup was assembled consisting of six separate photographs, one of which was Wilfredo Garcia Jr. On Wednesday January 18<sup>th</sup>, 2017, at approximately 6:00 p.m., Detective Jon Cooke # 2642, who had no knowledge of, or involvement in this investigation, administered a photo lineup to Sergeant Schweighardt, outside the presence of Detective Justin Lang and Detective Michael McBride. Sergeant Scwieghardt positively identified the photograph of



Wilfredo Garcia Jr. as the same defendant who operated the aforementioned all-terrain vehicle and fled from him on Monday January 16th, 2017.

Based on the positive identification from the photo lineup, coupled with sergeant Scweighardt's sworn police report, and video recorded evidence of the crime in progress obtained through publicly available source of Instagram, probable cause exists for the arrest of Wilfredo Garcia Jr. dob: 11/08/1989, Social Security , for the violation of reckless driving and the violation of fleeing and eluding police.

Video of the incident, posted on Instagram, has been preserved. A copy of the video will be recorded onto a CD and will be placed into City of Hollywood Police property for evidentiary purposes.

Sergeant Schweighardt completed Florida uniform traffic citation # A1KN3YP for the violation of reckless driving and uniform traffic citation # A1KN3ZP for the violation of fleeing and eluding police. The Florida uniform traffic citations will be placed into Hollywood records division for prosecution purposes.

The offense(s) set forth in the foregoing Affidavit are contrary to the statutes in such case made and provided, and against the peace and dignity of the State of Florida,
