I spoke to Lester, who told me he heard loud noises coming from outside, and when he went out see what was going on, he noticed Meyers pushing over scooters and motorcycles parked on along the roadway. Lester said he witnessed Meyers getting on several motorcycles that were parked and when he could not turn them on, he became upset and pushed them over.

I observed two motorcycles laying on their sides on roadway. One was a black Harley Davidson, bearing Ohio tag 1661, belonging to Randy Fischer (victim). The other was also a black Harley Davidson, bearing Michigan tag 70HD4, belonging to Mark Hollandsworth (victim). I observed damage to the right side handle bars of both motorcycles and what appeared like fresh scratched to the saddle bags of Hollandsworth's motorcycle. I did not observe any damage to scooters in the area.

I was unable to locate the owners to both the motorcycles, so I left a copy of my business card on each with the case number.

I took photographs of the damage and uploaded it to the Coban Server as evidence.

I spoke to Meyers and he was not making sense, and appeared to be intoxicated. When I asked him what happened, he told me he was just trying to go home, which he stated was in Clearwater Florida. Meyers was so intoxicated that he did not even recall coming down to Key West for spring break vacation. When I spoke to him about knocking over the motorcycles, he told me people don't know how to ride theirs bikes. I explained to Meyers that he did not push over a bicycle, he pushed over two Harley Davidson motorcycles.

I arrested Meyers and transported him to MCDC.

I charged Meyers with Criminal Mischief, violation of F.S.S. 806.13(1B2), for intentionally knocking over two Harley Davidson motorcycles and causing damage to each.

My BWC was activated.
