Before me this date personally appeared WILLIAMS, SEAN (16345) who being first duly sworn deposes and says that on 12 day of March, (year) 2017 at 700 HOLLYWOOD BLVD, HOLLYWOOD, FL 33019 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

At approximately 1843 hours on Sunday, March 12th 2017, I was dispatched while on-call to respond to the 700 block of Hollywood Boulevard, in the city of Hollywood, Broward County, Florida, in reference to a traffic crash with a suspected impaired driver. On my arrival at approximately 1937 hours, I made contact with Officer A. Laframboise (#3324) of the Hollywood Police Department in reference to the investigation.

Officer Laframboise advised me that after having been dispatched to a traffic crash, he was traveling west-bound over the intercostal bridge on Hollywood Boulevard (approximately the 700 block) where he observed the suspect vehicle (A white 1998 Lexus 2-door Car, Florida Tag: JT8CD32Z3W1002969). The suspect vehicle was facing east-bound, in the southern sidewalk over the bridge. The vehicle had a guard rail on it's left and a concrete wall on it's right, pinning it. He further advised that he observed the vehicle traveling in reverse, in movement in what he believed was an attempt to get the vehicle unstuck. After conducting a U-Turn, he made contact with the suspect vehicle - still in movement. He identified the operator of the vehicle as Jeffrey Phillip Sheffel by Florida Driver's License. Based on his observations, Officer Laframboise is my wheel witness to the driver being in actual physical control of the suspect vehicle. The following signs of impairment were noted by Officer Laframboise; The driver was dazed and confused, he detected the odor of an alcoholic beverage, watery eyes, and difficulty understanding instructions (such as instructions to sit so he would not wander into traffic). He noted the airbags had deployed, but that the driver had sustained no injuries. While speaking with the Officer, he avoided eye contact, which Officer Laframboise found notable. made, "I know I had too much to drink" and "I had too many beers". He advised he was a Diabetic, so Hollywood Fire/Rescue unit Rescue 40 responded and conducted an evaluation (FHW170312005987). There was no patient transport. He advised at one point he needed to use the restroom, and was escorted by a Hollywood Officer who remained in his presence and ensured he did not eat or drink anything.

I then spoke with Community Service Officer H. Hugelheim (#3116), who was conducting the traffic crash investigation. He advised me that his investigation revealed that the suspect vehicle, while traveling east-bound, drove into the southern side sidewalk. The vehicle drove with one set of tires on a guardrail, until the point where it fell entirely into the sidewalk.

I inspected the traffic crash scene, which was consistent with CSO Hugelheim's statements. I did observe at multiple points along the concrete barrier both scrape marks and tire scuff marks from the tire rotation. The front right fender had been pulled free while the vehicle was reversing, and remained in the sidewalk. The sidewalk was separated from the main roadway by a raised concrete barrier and was topped with a metal guard rail. The sidewalk was separated from the edge of the bridge by a concrete barrier with several protrusions for poles (including light poles). The damage was consistent with a vehicle traveling east-bound, getting stuck, and then reversing.

I was informed that during the crash investigation, the driver was placed in the back seat of a marked Hollywood Police vehicle. However, this was done both for his safety (there was a concern he might stumble into traffic) and to keep him protected from the

elements (rain), not to place him under arrest. He was not in handcuffs, and a Hollywood Officer routinely checked on him.

I activated by Body Worn Camera (BWC) and, in my presence, CSA Hugelheim made contact with the driver and completed his traffic crash investigation. He asked several questions pertaining to the traffic crash, such as where he was coming from (downtown) and where he was going (the beach). He seemed coherent to my observations and able to answer the questions. When CSA Hugelheim concluded his investigation, I made contact with the driver. I informed him who I was, and that I was not conducting a traffic crash investigation but was conducting a separate criminal investigation. He advised me that he understood. I asked if he wanted to exit the vehicle, and he said it was up to me. I asked the following questions of note;

Are you diabetic: Yes (he verified Rescue had checked him out)
Do you take any medications: Yes
Do you have any problems with your eyes: Needs glasses to see far.
Do you wear glasses: Yes (wearing)
Do you wear contact lenses (Hard or Soft?): Sometimes (Soft, not wearing now)
Are you under the care of a Doctor or Physician: Yes

I then requested the defendant exit the vehicle, and he complied. While speaking with him (asking him basic biographical information, such as name, date of birth, and contact phone numbers), I observed the odor of an alcoholic beverage coming from breath when he spoke and glassy eyes. I asked if he would be willing to walk off the bridge with me (as it was on an incline) and to the base of the bridge where my Patrol Vehicle
