At approximately 1843 hours on Sunday, March 12th 2017, I was dispatched while on-call to respond to the 700 block of Hollywood Boulevard, in the city of Hollywood, Broward County, Florida, in reference to a traffic crash with a suspected impaired driver. On my arrival at approximately 1937 hours, I made contact with Officer A. Laframboise (#3324) of the Hollywood Police Department in reference to the investigation.

Officer Laframboise advised me that after having been dispatched to a traffic crash, he was traveling west-bound over the intercostal bridge on Hollywood Boulevard (approximately the 700 block) where he observed the suspect vehicle (A white 1998 Lexus 2-door Car, Florida Tag: JT8CD32Z3W1002969). The suspect vehicle was facing east-bound, in the southern sidewalk over the bridge. The vehicle had a quard rail on it's left and a concrete wall on it's right, pinning it. He further advised that he observed the vehicle traveling in reverse, in movement in what he believed was an attempt to get the vehicle unstuck. After conducting a U-Turn, he made contact with the suspect vehicle - still in movement. He identified the operator of the vehicle as Jeffrey Phillip Sheffel by Florida Driver's License. Based on his observations, Officer Laframboise is my wheel witness to the driver being in actual physical control of the suspect vehicle. The following signs of impairment were noted by Officer Laframboise; The driver was dazed and confused, he detected the odor of an alcoholic beverage, watery eyes, and difficulty understanding instructions (such as instructions to sit so he would not wander into traffic). He noted the airbags had deployed, but

I activated by Body Worn Camera (BWC) and, in my presence, CSA Hugelheim made contact with the driver and completed his traffic crash investigation. He asked several questions pertaining to the traffic crash, such as where he was coming from (downtown) and where he was going (the beach). He seemed coherent to my observations and able to answer the questions. When CSA Hugelheim concluded his investigation, I made contact with the driver. I informed him who I was, and that I was not conducting a traffic crash investigation but was conducting a separate criminal investigation. He advised me that he understood. I asked if he wanted to exit the vehicle, and he said it was up to me. I asked the following questions of note;

Are you diabetic: Yes (he verified Rescue had checked him out)

Do you take any medications: Yes

Do you have any problems with your eyes: Needs glasses to see far.

Do you wear glasses: Yes (wearing)

Do you wear contact lenses (Hard or Soft?): Sometimes (Soft, not wearing now)

Are you under the care of a Doctor or Physician: Yes

I then requested the defendant exit the vehicle, and he complied. While speaking with him (asking him basic biographical information, such as name, date of birth, and contact phone numbers), I observed the odor of an alcoholic beverage coming from breath when he spoke and glassy eyes. I asked if he would be willing to walk off the bridge
