MHERE HE HAD EACH VICTIM STEP OUT OF THEIR RESPECTIVE VEHICLES, SEARCHED EACH VEHICLE, AND THEN RELEASED EACH OF THE DRIVERS WITHOUT ANNOUNCING ANY OF THE CALLS OVER THE POLICE RADIO OR ISSUING ANY CITATIONS TO ANY OF THE DRIVERS. AT APPROXIMATELY 2108 HOURS, OFFICER JOSE R. ACOSTA ACTIVATED HIS EMERGENCY EQUIPMENT AND CONDUCTED A TRAFFIC STOP ON THE UNDERCOVER AGENT AT THE CORNER OF NW 3 AVENUE AND 22 STREET. OFFICER JOSE R. ACOSTA WAS OBSERVED TAKING THE UNDERCOVER AGENT OUT OF HIS CAR AND PLACING HIM SPREAD-EAGLE AGAINST THE VEHICLE. OFFICER ACOSTA THEN SEARCHED THE UNDERCOVER AGENTS POCKETS AND REMOVED ALL HIS BELONGINGS INCLUDING THE PLANTED MARKED U.S CURRENCY. AT APPROXIMATELY 2110 HOURS, OFFICER ACOSTA WALKED THE UNDERCOVER AGENT TO THE PATROL VEHICLE WHERE HE PLACED HIM IN THE BACK SEAT OF THE VEHICLE UNHAND CUFFED AND HAD HIM REMAIN AS HE COMMENCED SEARCHING HIS VEHICLE. AT APPROXIMATELY 2113 HOURS, OFFICER ACOSTA WALKED BACK TO HIS MARKED PATROL VEHICLE AND CLEARED THE AREA LEAVING THE UNDERCOVER AGENT STANDING ON THE SIDEWALK. AT APPROXIMATELY 2115 HOURS, THE UNDERCOVER AGENT NOTIFIED NEARBY MONITORING UNITS THAT THE OFFICER HAD TAKEN THE MONEY. THE OPERATION CONTINUED UNTIL 2301 HOURS WHEN OFFICER ACOSTA ENDED HIS TOUR OF DUTY AT THE CITY OF MIAMI POLICE CENTRAL STATION. OFFICER ACOSTA LEFT THE STATION WITHOUT DECLARING, REPORTING, OR OTHERWISE DOCUMENTING ANY OF THE PROPERTY OR MONEY TAKEN FROM THE UNDERCOVER AGENT DURING THE TRAFFIC STOP. MULTIPLE UNDERCOVER UNITS FOLLOWED AND SURVEILLED THE OFFICER UNTIL HE ARRIVED AT 1036 NW 6 STREET (SECONDARY RESIDENCE) AND WAS TAKEN INTO CUSTODY BEFORE ENTERING THE BUILDING. DURING A POST MIRANDA INTERVIEW, OFFICER ACOSTA ADMITTED HE FURTHER ADMITTED OFFICER ACOSTA FURTHER ADMITTED AS THE INTERVIEW PROGRESSED, OFFICER ACOSTA ADMITTED OFFICER ACOSTA, WHILE ARMED WITH HIS CITY OF MIAMI ISSUED FIREARM, DID ENTER A CONVEYANCE (A MOTOR VEHICLE) WITH THE INTENT TO COMMIT A THEFT OF U.S CURRENCY.
