On 05/28/17, at approximately 1214 hours, I responded to 4700 NW 26th Ave in reference to a civil assist. Upon arrival, I spoke with W/M Lewis Bennett.

Bennett contacted BRPD for a civil standby while he collected items from his in-laws home. He brought his 9 month infant,

Lewis advised that he had previously made a report with PBSO for the items that were taken. (Unknown case number) I advised him that I would stand by but could not guarantee that his items would be returned.

Lewis made contact with his sister-in-law, W/F Dayana Rodriguez. Lewis spoke to Dayana and asked for a computer, an Ipad, an engagement ring, clothes, and handbags. Lewis advised Dayana that he knows those items were taken from his residence and he had the security cameras to prove it. Dayana denied taking the items and invited Lewis into the residence to check for the disputed property. Another sister-in-law, W/F Elizabeth Rodriguez, began shouting for Lewis to get out of the residence. Also present were W/F Amparo Alvarez and W/M Eduardo Rodriguez.

All came outside as the in-laws continued to yell at Lewis. Elizabeth repeatedly stated that Lewis killed her sister. I was unsure initially what she was talking about, but was told by Dayana that her sister was the one missing while at sea with Lewis. Eventually, Lewis and I decided that it was best that he leave since the property was not going to be handed over. Lewis agreed that it was best and left without incident.

Investigator Munchel of the US Marshals was contacted and advised of today's incident. He advised that Lewis is under investigation for the disappearance of his wife, W/F Isabella Hellman, while at sea.
