
ON FRIDAY, JUNE 30, 2017, THE DEFENDANT VOLUNTARILY RESPONDED TO THE MDPD HOMICIDE BUREAU WHERE SHE PROVIDED A POST-MIRANDA STATEMENT ADMITTING TO SMOKING CRACK COCAINE IN THE PRESENCE OF THE VICTIM PRIOR TO HER DEATH. DURING THE COURSE OF THE INTERVIEW, THE DEFENDANT ADVISED THIS INVESTIGATOR THAT SHE WAS PLANNING ON RETURNING TO INDIANAPOLIS, INDIANA, IN THE NEXT SEVERAL DAYS, WHERE SHE WAS FROM AND WOULD BE HOMELESS.

ON SUNDAY, JULY 02, 2017, CONTACT WAS MADE WITH THE DEFENDANT, WHO ADVISED THAT SHE WAS RETURNING TO INDIANAPOLIS, INDIANA, ON A GREYHOUND BUS, WHICH WOULD BE LEAVING AT APPROXIMATELY 6:00 P.M., TODAY. HOMICIDE INVESTIGATORS RESPONDED TO THE DEFENDANTS LOCATION AND PLACED HER INTO CUSTODY WITHOUT INCIDENT.

THE DEFENDANT WAS ARRESTED AND TRANSPORTED TO TKG VIA MDPD HOMICIDE BUREAU.

IT SHOULD BE NOTED THAT THE DEFENDANT DOES NOT HAVE ANY TIES TO THE COMMUNITY.
