Two subjects, Angel Agarrat aka Angel Lii DOB 06/22/1991 and Justin J. Jackson aka Justin Lii DOB 03/15/1987, bought the website domains www.septembermgmt.com and www.septembermagmt.com. Mr. Cho conducted his own investigation after observing a discrepancy between the domain name used in the email and the domain name being utilized by the actual Mr. Dickins and was able to determine that the request was fraudulent. During the ruse, the subjects created the fake domain: leomessimanagement.com. The subjects utilized it to create a fictitious email address to impersonate Guillermo Marin who represents professional soccer player Lionel Messi. They brought in the fictitious "Marin" using email address GMarin@LeoMessiManagement.com to add a layer of verisimilitude to their scheme by pretending that Adele was working together with Lionel Messi for the charity auction where the shoes were purportedly to be sold.

Ultimately shoes from Hamilton were sent to the subjects under Fedex tracking number 776773810230. The package was signed for under the name "A Agraat." In addition, shoes from Oladipo and George were also shipped out to the subjects. The shoes were shipped out as Mrs. Holtz believed that she was dealing with the actual Johnathan Dickins. On July 21, 2016, some of the shoes were returned to the CAA office in Miami Beach, Florida. Surveillance video captures a male returning the shoes that matches Subject Jackson/Lii. Your Affiant made contact with Mr. Nathan and Mrs. Holtz who completed affidavits confirming that they had received the fraudulent email. Mr. Nathan's statement revealed that the two pair of shoes that where shipped from Oladipo and the two pairs from Hamilton were valued at approximately \$2000-\$5000 each. The subjects ultimately did attend the Fabolous concert on June 23, 2016. They used the passes that they obtained to go backstage. Upon uncovering the ruse, Ms. Keily contacted an on-scene representative. The representative had the subjects removed from the venue. Your Affiant made contact with Ms. Keily who confirmed that she had received the fraudulent email and confirmed the events listed above. In addition, after the subjects were arrested in separate case on May 7, 2017 their cell phones were seized. A subsequent forensic examination of Mr. Lii's phone showed several photos taken at the Fabolous concert including one of Mrs. Lii with Fabolous himself. The metadata related to the photographs provided GPS coordinates that matched the venue where the concert was being held, and provided the date and time the photos were taken as the same date and time of the concert.

On August 25, 2016 the subjects sent an email from **JDickins@septembermgmt.com** to Eli Davis at eli@specialbrand.com. Mr. Davis represented international recording artist Anthony Hamilton, and the subjects were trying to obtain valuable special edition shoes. The email reads as follows:

Ms. Veazey's stated that the shoes the subjects were trying to obtain are very rare, in high demand and were valued at \$10,000.00. Your affiant conducted research, and found that the shoe was in fact being listed for \$10,000.00 on the secondary market.

The billing contact was listed as Angel Agarrat, with an address of 2728 North 24 Ave in Hollywood, FL. The records show that the email service for the domain was provided by Microsoft Corporation.com via their email essentials program. The domain was purchased using a credit card ending in 3119 assigned to Angel Agarrat. The monthly service fee was paid using four different sources: a credit card ending in 4250 assigned to Angel Agarratt, a credit card ending in 7339 assigned to Angel Agarrat, a debit card ending in 6935 assigned to Angel Agarrat with a billing address of 20501 NW 17th Ave, Miami Gardens, FL 33056, and an ACH draft from a Navy Federal Credit Union checking account ending in 1404, with a recorded FL Driver's License number of

That Driver's License number is assigned to the subject Justin James Jamar Jackson later named Justin Lii. Florida DHSMV records show that Jackson/Lii legally changed his name to Justin Lii in 2016. Records for the Navy Federal Credit Union Account used to pay for the email service show that the account was opened by Justin J. Jackson with sponsorship from Angel A Agarrat. These records also reflect Jackson/Lii's subsequent changing of his name. These records list Jackson/Lii's telephone number as 954-822-4568. Records related to the 6935 debit card show that it was assigned to a U.S. Bank checking account. Records from U.S. Bank confirm that account belongs to Angel A Agarrat, lists her email as angel.agarrat@gmail.com, and lists her address as 20501 NW 17th Ave, Apt 103 Miami Gardens, FL 33056. This is the same address that was provided as a delivery address for some of the goods that the subjects were trying to obtain. The bank records also corroborate the charges from Microsoft Corporation.

The septembermagmt.com domain was registered under the name "Jonathan Dickins" with a contact telephone number of 646-982-5911, and an assigned Shopper ID of 119189500. The domain was purchased using the same credit card ending in 3119 assigned to Angel Agarrat as the other domain. The domain was locked by Microsoft Corporation after it was opened under suspicions of fraudulent activity. Domain lookup records show that leomessimanagement.com was registered by Justin Jackson with the email address of jdickins@septembermgmt.com and the same 646-982-5911 telephone number.

A background check revealed that Jackson/Lii and Angel Agarrat have also both been

sued civilly for losses resulting from impersonation schemes similar to this case.

The Rolling Loud Festival was being held at Bayfront Park in the city of Miami, and Kendrick Lamar was preforming on May 6^{th} at the festival. Mr. Alba believed that the request

was not legitimate and made contact with the actual Jonathan Dickins and was able to confirm that the email was not genuine. Your Affiant was contacted shortly thereafter and was made aware of this request. Your Affiant made contact with Mr. Alba and a proactive operation was initiated.

Your Affiant contacted the subjects on the cell phone that was provided to the event managers. Your Affiant acted as if he was a manager at the Rolling Loud Concert and would provide them with backstage access as requested. Your Affiant stated that they will be able to pick up their passes between 7:00 pm and 9:00 pm on May 6, 2017 at the event venue. Mr. Lii confirmed that they will pick them up during that time frame.

On May 6, 2017 your Affiant was contacted by the subjects, via cellular phone. When the subjects arrived as planned, Mr. Lii began speaking to your Affiant. He stated that he was the associate of Mr. Dickins and that he was working with his important clients all day. Present during the conversation was Mrs. Angel Lii and Hayle Henegar. Your Affiant proceeded with the subjects and Ms. Henegar to the special entrance reserved for individuals who were picking up passes that were provided by request the festival entertainers. The passes were valued at a minimum of \$250.00 each. Once there, all three were provided passes and they were instructed to enjoy the show. At this time, the Lii's and Mrs. Henegar were detained and escorted to a Bayside Office to be interviewed.

Mrs. Henegar stated that she was just a friend of the Lii's and that she was invited to attend the festival. Mrs. Henegar stated that Mr. Lii worked with celebrities and stated that he stated they can get comped to come into the festival. Mrs. Henegar stated that she became concerned upon hearing your Affiant (working undercover as a production manager) converse with Mr. Lii when Mr. Lii did not know details about the managers he was purporting to work with. Mrs. Lii was also present during this conversation.

Mr. & Mrs. Lii were both interviewed separately and provided conflicting and untruthful information. Mrs. Lii established that her credit card accounts were in her control and if Mr. Lii made any charges she would have to be aware of them. Mrs. Lii also stated that she goes through her credit card statements to check for any unauthorized charges. Mrs. Lii stated that she does not know if Mr. Lii has any credit card accounts. When Mr. Lii was being taken into custody he purposefully destroyed his cell phone by crushing it. Mr. Lii claimed that the phone never worked but your Affiant observed the phone working immediately prior to Mr, Lii being

taken into custody.

The Lii's were placed in the rear of a police vehicle for transportation to a correctional facility. While in the cruiser but before transportation began, Mr. Lii stated to Mrs. Lii that he intentionally destroyed the phone to prevent it from being viewed. Both Lii's discussed destroying evidence that was at their residence including computers and paperwork. These statements were audio recorded.

Both Mr. and Mrs. Lii's cell phones were seized as evidence. They were forensically examined by an examiner at the Miami Electronic Crimes Task Force at the United States Secret Service Miami Field Office, pursuant to a search warrant.

A search warrant for email content for the domains of septembermgmt.com, septembermagmt.com, leomessimanagement.com and email accounts JDickins@septembermgmt.com, JDickins@septembermagmt.com, GMarin@LeoMessiManagement.com was issued to GoDaddy. On June 13, 2017, your Affiant was contacted by legal counsel for GoDaddy who advised that email for all of the accounts were being serviced by Microsoft 365 email services. The results of that warrant are still pending.

WHEREFORE, for the foregoing reasons, "Your Affiant" requests a warrant for the arrest of Justin Lii for three counts of Identity Fraud more than 20 Victims, fourteen counts of Identity Fraud, one count of Unlawful Use of a Two-Way Communications Device, and one count of Organized Scheme to Defraud, based on the probable cause herein shown. "Your Affiant" requests a warrant for the arrest of Angel Lii for seventeen counts of Identity Fraud, one count of Unlawful Use of a Two-Way Communications Device, and one count of Organized Scheme to Defraud, based on the probable cause herein shown.
