	<p>On 01/23/2018, I responded to 810 South Lipona Road in reference to a domestic disturbance call. The call notes indicated that the complainant's ex-girlfriend was in his home, breaking things and tearing up his room.</p> <p>I arrived on scene and made contact with the complainant, Deondre Francois. All parties on scene were separated and no one advised they needed EMS, so I proceeded to speak with Francois. Francois advised the following: Francois and his girlfriend, Diamond Lindsey, have been dating for approximately 9 months. Lindsey moved in with Francois (at the incident location) approximately 3-4 months ago. On today's date, 01/23/2018, Francois and his friend, Zaquandre White, arrived home and began "relaxing and watching ESPN". Lindsey arrived at the residence and began arguing with Francois about a past argument. Francois asked Lindsey to leave which caused her to become angry. Lindsey began</p>

breaking things and threw a vase across the room, breaking it. Lindsey attempted to pull a television off of the wall. Francois tried to stop Lindsey by picking her up, "like a hug". Francois tried to carry her outside so that she would not break anything else. Lindsey began to "swing" at Francois and he let her go. Lindsey started ripping her shirt, while stating, "I'm going to call the cops for domestic violence." Francois called the police because Lindsey continued to try to break things in the residence. Francois provided a sworn written statement and requested that I take photographs of the scene and damaged property. I took photographs of the scene and damaged property with my department issued camera #3006.

I made contact with Lindsey, who advised the following: Francois and Lindsey have been dating for approximately 1 year and Lindsey moved in with Francois approximately 6-7 months ago. On today's date, Francois became upset with Lindsey because his friend tried to "talk to her". Francois told Lindsey that she could not speak with another guy. Francois broke down the bedroom door, picked Lindsey up, through her onto the ground, cut her forearm, and tried to physically kick her out of the residence. Lindsey advised that she found out she was 9 weeks pregnant at the hospital (with Francois' child). Lindsey had previously told Francois about the pregnancy, so he should have known. (Lindsey's pregnancy was not showing due to the early term). Lindsey provided a sworn written statement and requested I take photographs of the cut on her forearm. I took photographs of Lindsey's injury with my department issued camera #3006. Lindsey advised she did not want to pursue charges and indicated such on her sworn written statement. While speaking with Lindsey, she advised me that she did not want Francois to get into "trouble trouble", but she did want me to speak with him "to scare him a little". Lindsey then asked if Francois would get into trouble if he "smoked weed". Lindsey advised the Francois had "smoked the weed earlier".

I made contact with White, who advised the following: White and Francois were hanging out in the residence when Lindsey came home and began arguing with Francois. Lindsey was upset and began throwing glasses everywhere and broke a vase. Lindsey then locked herself in Francois' room and tried to break a television. Francois kept asking Lindsey to leave, but she refused and continued to break things within the home. White could hear Lindsey say that she was calling the police and would tell the police that it was domestic violence. Francois only put his hands on Lindsey when he tried to prevent her from breaking things in the home, and when he had to defend himself when Lindsey "swung at him". White provided a sworn written statement.

Francois advised me that Lindsey did tell him that she was pregnant, but never provided any documentation to prove it. Francois stated he did not believe Lindsey because she was known to make up lies. Lindsey was not showing any signs of the pregnancy. When I asked Francois about the cut on Lindsey's forearm, he stated that she cut herself when she broke the vase. Lindsey stated that she had sustained the cut when Francois was attempting to "drag her out of the house". Based on the conflicting statements and lack of independent witnesses, I was unable to establish probable cause to make an arrest for battery.

Both Francois and Lindsey have established residency at this location, so I was unable to make either party leave the scene. Francois agreed to stay with White for the night and left the scene with White. I provided both Francois and Lindsey with a case number on department issued business cards. I provided Lindsey with a Victim's Rights Pamphlet and Lindsey completed the request for confidentiality page.
