# AFFIDAVIT IN SUPPORT OF ARREST WARRANT

## The Subjects

Mariano Fernandez (hereafter "FERNANDEZ") is the Director of the Building Department for the City of Miami Beach (hereafter "Miami Beach"). As Director of the Building Department, FERNANDEZ has all of the statutory authorities of "Building Official" for Miami Beach, which include final say on permitting and inspections. FERNANDEZ joined the City in May 6, 2013, after five years as the Building Official for the City of Miami. FERNANDEZ is a licensed Professional Engineer. FERNANDEZ's email is marianofernandez@miamibeachfl.gov.

Riutel Florida Inc. (hereafter "RIU" or "the RIU") is a registered for-profit corporation in the State of Florida, with Tax ID Number

RIU's registered agent is Gary Brown.

RIU is the owner of Hotel Riu Plaza Miami Beach, a 284-room hotel located at 3101 Collins Ave., in Miami Beach, Florida (hereafter "Riu Miami Beach"). RIU is a wholly owned subsidiary of Riu Hotels and Resorts, which is a Spanish Corporation, headquartered in Mallorca. Riu Hotels and Resorts is among the largest hotel chains in the world, with over one hundred hotels in 19 countries. Riu Hotels and Resorts uses the designation "Plaza" to refer to its hotels located in cities.

Luis Riu Guell, Jr. (hereafter "LUIS RIU") is part-owner of Riu Hotels and Resorts. He and his sister Carmen Riu inherited Riu Hotels and Resorts from their father. LUIS RIU's email address is lriug@riu.com.

Ricardo Luque Ferrandez (hereafter "LUQUE") is the Managing Director of Riu Plaza (City) Hotels. In addition to the Miami Beach location, Riu "Plaza" Hotels are in Guadalajara, Mexico; Manhattan, New York; Berlin, Germany; Panama City, Panama; and Dublin, Ireland.

# **Summary of the Crime**

Over the course of nineteen (19) months, Mariano FERNANDEZ solicited and accepted unlawful benefits, for himself and others, from the RIU. The unlawful benefits were at the direction of RIU managers Alejandro SANCHEZ and Ricardo LUQUE, and with the explicit permission of owner LUIS RIU and CEO Pepe MORENO. The unlawful benefits were offered as a reward for FERNANDEZ's official action as Building Director. Your Affiants are requesting the Court's permission to arrest FERNANDEZ, the RIU, SANCHEZ, and LUIS RIU for one (1) count of Unlawful Compensation and the RIU, FERNANDEZ, SANCHEZ, and LUIS RIU for one (1) count of Conspiracy to Commit Unlawful Compensation.

## **Your Affiants**

Your Affiant, Detective Ricardo Arias, is a Detective with the Miami Beach Police Department. Detective Arias has been with the Miami Beach Police Department for 21 years. During that time, Detective Arias has been a Detective for 17 years. Detective Arias has experience conducting complex criminal investigations involving narcotics trafficking, money laundering, homicide, economic crimes, cyber-crimes, election-related crimes and public

corruption. Your Affiant is also a computer forensic examiner and routinely conducts computer forensic examinations. Your Affiant is currently Secret Service, Miami Electric Crimes Task Force Task Force Officer and a Specially-Designated State Attorney's Office Investigator of the Miami-Dade State Attorney's Public Corruption Task Force (hereafter "SAPCTF").

Your Affiant, Matthew Ambre, court ID # 002-514, is a detective with the City of Miami Beach Police Department. Your Affiant has been employed as a Police Officer for approximately twenty-three (24) years and is currently assigned to the Internal Affairs Unit and detached to the SAPCTF. Your Affiant has received both general and specialized training in investigations. Your Affiant has been a detective for twenty years, and has been the lead detective or assisting detective in hundreds of investigations including public corruption, frauds, burglaries, robberies, homicides, and sexual batteries.

# **Background Information**

This Affidavit is based upon information known personally to Your Affiants, Ricardo Arias and Matthew Ambre, both Detectives from the Miami Beach Police Department and the SAPCTF, and information obtained from others who have investigated this matter and/or have personal knowledge of the facts herein. Your Affiants have participated in this investigation, spoken with other law enforcement agents, and reviewed records and transcripts related to this investigation. Your Affiants have set forth those facts necessary to establish probable cause in support of this search warrant application, and not every detail known to Your Affiants and other law enforcement officers concerning this investigation is stated herein.

# Summary of Investigation

Your Affiants have investigated benefits exchanged between Riutel Fla. Inc. ("RIU") and Mariano FERNANDEZ, the Director of the Miami Beach Building Department (hereafter referred to as "Building Director"), during and after RIU's renovations to their Miami Beach hotel. The titles "Building Director" and "Building Official," are used interchangeably in this Affidavit.

RIU owns a hotel located at 3101 Collins Avenue, in Miami Beach, Florida, which operates under the name Hotel Riu Plaza Miami Beach (hereafter the "Riu Miami Beach"). The

Riu Miami Beach has 284 guestrooms. Between October 2013 and June 2016, the Riu Miami Beach underwent a major renovation and rebranding. During the renovation, RIU had difficulties with the permitting process with the Miami Beach Building Department and the Miami Beach Fire Department. FERNANDEZ, as Director of the Building Department, helped guide RIU through the permitting and inspection process, including taking official action to assist the RIU.

As a reward for his guidance and direction, RIU offered FERNANDEZ (and his associates) multiple complimentary and significantly discounted rooms at the Riu Miami Beach and other RIU properties. Also in reward for FERNANDEZ's assistance, RIU offered a significantly reduced rate for the entire Miami Beach Building Department to stay at an all-inclusive RIU resort in Punta Cana, Dominican Republic, in 2015, and in Playa del Carmen, Mexico, in 2016.

# Miami Beach's Records Management Software

In 2014 and 2015, Miami Beach used a computerized permit managing software called Permits Plus. Among other things, the Permits Plus system recorded permits, inspections, permit fees, and permit payments. Screen shots from Permits Plus are pasted throughout this affidavit to illustrate actions taken by FERNANDEZ, his employees at the Building Department, and other Miami Beach employees. Your Affiants have learned that whenever someone inputs information on Permits Plus, it displays their username in a data field titled "Entered By:". Your Affiants learned that FERNANDEZ's username on Permits Plus is "BUILFERM" (Your Affiants learned that "BUIL" indicates that the user is from the Building Department, "FER" are the first three letters of the user's last name, and "M" is the first letter of the user's first name).

## Summary of Unlawful Benefits

Your Affiants have discovered that the RIU offered a variety of unlawful benefits to Building Director FERNANDEZ and his employees at the Miami Beach Building Department as a reward for FERNANDEZ's action, guidance, and direction during the renovation process. Specifically, Your Affiants have discovered that RIU provided the following to FERNANDEZ, FERNANDEZ's family, FERNANDEZ's employees, and FERNANDEZ's colleagues:

- Two (2) free nights for FERNDANDEZ and his wife at the Riu Miami Beach;
- Four (4) free nights for FERNANDEZ and his wife in an upgraded Jacuzzie Suite at the Riu Palace Bavaro all-inclusive resort in Punta Cana, Dominican Republic;
- Four (4) free nights for FERNANDEZ and his wife in an upgraded Jacuzzie Suite at the Riu Palace Mexico all-inclusive resort in Playa Del Carmen, Mexico;
- Two (2) free nights at the Riu Miami Beach for Sandra Meyer, one of FERNANDEZ's employees at the Building Department;
- One (1) free night at the Riu Miami Beach for Beatriz Dooley, one of FERNANDEZ's employees at the Building Department;
- Two (2) discounted nights at the Riu Miami Beach for Karla Santana, one of FERNANDEZ's employees at the Building Department;
- Two (2) free nights at the Riu Miami Beach for Iliana Oliva, one of FERNANDEZ's colleagues from the City of Miami Building Department;
- Two (2) free nights at the Riu Miami Beach for Yeneris Orta, one of FERNANDEZ's employees at the Building Department;
- One (1) free night at the Riu Miami Beach for Adolf Rahmer, a relative of one of FERNANDEZ's colleagues;
- Four (4) free nights at Riu Palace Antillas, Aruba, for Gema Aranda, one of FERNANDEZ's employees at the Building Department;
- A heavily discounted rate on five (5) nights at the Riu Palace Bavaro all-inclusive resort in Punta Cana, Mexico, for Sonia Perez, one of FERNANDEZ's employees at the Building Department.
- A heavily discounted rate on one hundred ninety two (192) nights for Building Department employees (along with their family and friends) at the Riu Palace Bavaro all-inclusive resort in Punta Cana, Dominican Republic;
- A heavily discounted rate for Building Department employees (along with their family and friends) at the Riu Palace Mexico all-inclusive resort in Playa del Carmen, Mexico, (this benefit included forty-four rooms and most guests stayed for four nights).

Your Affiants discovered that the RIU provided all of the benefits outlined above either directly to FERNANDEZ or at FERNANDEZ's request. Your Affiants have set forth evidence of each of these unlawful benefits below, generally in chronological order.

# Probable Cause and Specific Facts of the Investigation

Your Affiants began investigating the RIU's unlawful benefits to FERNANDEZ after an anonymous complaint was sent to the City of Miami Beach. Miami Beach immediately referred the complaint to the SAPCTF. SAPCTF investigators interviewed FERNANDEZ in his home at the beginning of the investigation; some of FERNANDEZ's statements are included in this Affidavit.

Pursuant to the investigation, Your Affiants retrieved FERNANDEZ's official Miami Beach email records, under the email address marianofernandez@miamibeach.gov. Your Affiants have pasted select emails from FERNANDEZ's account throughout this Affidavit.

Pursuant to the investigation, Your Affiants also obtained a search warrant to seize and search official RIU emails for the following individuals:

- > Ricardo LUQUE's official RIU emails, under the email address rluquef@riu.com.
- > Don LUIS RIU's official RIU emails, under the email address lriug@riu.com.
- > Jose "Pepe" MORENO's official RIU emails, under the email address pmoreno@riu.com.
- > Alejandro SANCHEZ del Arco's official RIU emails, under the email address asanchez@riu.com.

Your Affiants have pasted select emails from LUQUE, RIU, and MORENO's account throughout this Affidavit.

Your Affiants have subpoenaed records from the RIU, the City of Miami Beach, and other private corporations. Your Affiants have included records in this Affidavit where they assist to illustrate Your Affiants' probable cause that crimes have been committed.

## Timeline of Renovations to the Riu Miami Beach

Your Affiants learned that the upper management at the RIU decided in early 2013 to renovate guestrooms at the Riu Miami Beach. The RIU applied for a Master Permit for complete renovations of all 284 Riu Miami Beach guestrooms on October 28, 2013. The Master Permit application was signed by owner LUIS RIU. While the master permit application was still pending, and without approval from the City of Miami Beach, RIU began renovating the Riu Miami Beach. By May 16, 2014, more than one hundred of the guestrooms had been completely renovated. These renovations were completed without any safety inspections or verification that they complied with the applicable building codes. The RIU was assigning guests to rooms adjacent to unprotected construction areas.

On Friday, May 16, 2014, Miami Beach Fire Inspector Joseph Bacallao performed an unannounced annual inspection of the Riu Miami Beach. Mr. Bacallao discovered that the Riu

Miami Beach was undergoing unpermitted renovations. According to Mr. Bacallao, the Riu Miami Beach was unsafe for guests, yet it was at full capacity. As a result, the Miami Beach Fire Department ordered RIU to stop work and re-accommodate the guests within four days.

The RIU was facing a spectrum of repercussions from the Building Department for renovating the Riu Miami Beach without obtaining the proper permits. According to the Miami Beach Building Code, the RIU was required to pay a \$100 fine and twice the fees associated with the necessary permit:

Double fees. Any person who commences any work on a building, structure . . . before obtaining the building official's approval or the necessary permits shall be subject to a penalty of 100 percent of the required permit fee, in addition to the required permit fees, plus a penalty for the first, second and subsequent offenses as outlined in appendix A.

Miami Beach Code of Ordinances §14-61(b). In addition to the fines and double fees, Building Director FERNANDEZ could have required the RIU to tear down the already-completed work and start from scratch. The least-onerous outcome would be for the Building Department to permit the RIU to hire a private engineer to examine and certify that all of the construction was done to code.

On Tuesday, May 20, 2014, Building Director FERNANDEZ hosted a meeting to address the RIU's unpermitted renovation project, and to prescribe the RIU's conduct moving forward with the project. RIU Regional Vice President Alejandro SANCHEZ represented the RIU at the meeting. Miami Beach Fire Chief Virgilio Fernandez and Fire Marshal Juan Meizoso attended the meeting. The RIU's general contractor, Juan Velez, and project engineer, Rey Miranda, also attended. The meeting was held in FERNANDEZ's office. As a result of the meeting, Building Director FERNANDEZ permitted RIU to commission engineer Rey Miranda to inspect the completed guestrooms and certify that they comply with the building code.

After the meeting, project engineer Rey Miranda sent a memorandum to FERNANDEZ and the Fire Department, which memorialized what was discussed and decided in the meeting. A copy of Mr. Miranda's memorandum is pasted on the next two pages:

Dear Building Director Fernandez and Fire Chief Fernandez:

This letter is to memorialize the recent circumstances of this property and to formalize an agreement between the Owner, Building Department and the Fire Department.

## CIRCUMSTANCES:

My firm has submitted construction documents for the guestroom renovation of the RIU Hotel Florida Beach. The plans are currently signed-off and waiting for Building permit.

An exploratory demolition permit BD140033 was approved on October 13, 2013 to Inspect and determine the existing conditions so that upon receipt of the construction permit work could commence immediately.

The contractor under the pressure of the RIU Hotel proceeded with the complete demolition and full construction of 100+ guestrooms prior to having obtained the approved permit.

On Friday, May 16, 2014 Fire Inspector Joseph Bacaliao performed his annual inspection of this hotel discovering vertical and horizontal demolition penetrations and contacted Fire Marshal Juan Meizoso, Fire Chief Virgilio Fernandez and Building Operations Manager Antonio "Tony" Gonzalez. Fire Marshal Juan Meizoso contacted me on the evening of Friday May 16, 2014 requesting for me to conduct an inspection at the hotel with him that night.

That same evening it was decided that all guests would vacate the hotel by checkout time Tuesday, May 20th, 2014. A Fire Watch was implemented with two firemen for the hotel and two security guards on each floor. The Fire Watch would remain in place until all guests would vacate. In a subsequent meeting yesterday with Fire Chief Virgilio Fernandez, Fire Marshal Juan Meizoso, Building Director Mariano Fernandez, Contractor Juan Velez, Owner's Representative Alejandro Sanchez and myself, it was further

determined that hotel staff, approximately twenty-five (25) employees, could remain working at the hotel during working hours under my responsibility and that of the RIU Hotel management. Two security guards would be allowed to remain in the hotel during over-night hours.

## AGREEMENT:

Building Director Mariano Fernandez has permitted for me to perform the inspections for all built-out areas and will require my certification for adherence to Code. Prior to the Fire Department performing their inspection to fire sprinkler, fire alarm, and any other elements that are deemed necessary. I shall provide as built plans showing compliance with all codes prior to inspecting, including comdor wall ratings, demising walls, vertical opening and life safety systems. The futures build-outs after permit approval is obtained will be performed by The City of Miami Beach unless otherwise agreed to at a later date.

Reoccupation of the Hotel will occur on a floor by floor basis from the bottom up always leaving a floor above as a buffer floor from the floor of construction as detailed in the perrol set.

Although none of the other attendees to the meeting signed Mr. Miranda's memorandum, Mr. Miranda testified that it accurately reflected what was decided at the meeting.


Your Affiants discovered that FERNANDEZ's Building Department never assessed double fees on the RIU's Master Permit. Rather, the RIU was allowed to apply for a (cheaper) "Partial Demolition Permit" on May 23, 2014, and double fees were reportedly assessed on that Partial Demolition Permit. As of May 2014, the Master Permit fees were over \$45,000. Had FERNANDEZ's Department assessed the proper fees, the RIU would have owed an additional \$45,000 in fees to Miami Beach. By contrast, the Partial Demolition Permit fees were only \$10,000, so the double fees assessed for the Partial Demolition Permit were \$10,839.80. By assessing double fees on the Partial Demolition Permit rather than the Master Permit, FERNANDEZ's department saved the RIU roughly \$35,000.

Your Affiants, with the assistance of Miami Beach employees, have searched Permits Plus and determined that Partial Demolition Permit BD140276 was never approved. Rather, it sat in applied-for status until FERNANDEZ simply closed the permit on September 17, 2014. A screenshot memorializing FERNANDEZ closing BD140276 is pasted below (highlighted in red):



Renovations continued, and the Riu Miami Beach remained closed, through February 2015. Between May 2014 and February 2015, the RIU expanded the scope of the renovations. In addition to the guestrooms, they renovated the lobby area, and began renovations to the pool and pool bar. The RIU had difficulties with the permitting and inspection process, primarily with the fire department. On at least one occasion, the RIU was required to stop work and obtain a new permit. According to RIU employees and records, the RIU received assistance and guidance from Building Director FERNANDEZ throughout the renovation.







Your Affiants learned that User ID "BUILARAG" belongs to Gema Aranda. The text is "CGC can obtain permit per B.O. MVF." Mr. Avalos testified that "CGC" means construction general contractor, "B.O." means building official, and "MVF" means Mariano Victor FERNANDEZ.







FERNANDEZ assisted the RIU even more in the final stretch of the process. As the hotel was getting close to reopening, Your Affiants have probable cause to believe that FERNANDEZ used his influence to convince inspectors to sign off on permits, as well as signed off on permits himself.

During the months of November and December of 2014 and January of 2015, the construction and renovation progress at the Riu Miami Beach was delayed due to the ongoing review of deficient plans submitted to the Miami Beach Fire Department ("Fire") by the RIU. The granting of the Riu Miami Beach's reopening depended on Fire's approval of the hotel's fire alarm system. The RIU was required to submit plans for the Riu Miami Beach's fire alarm system, which were included in the Riu Miami Beach's master renovation plans. The fire alarm system plans were first submitted to Fire on August 11, 2014. The fire alarm plan review process

Email communications between LUIS RIU and his employees reveal an ongoing frustration with the Miami Beach Fire Department's inspection and approval of the Riu Miami Beach's fire alarm permit under permit FP1510104. Your Affiants believe the email communications pasted below between LUIS RIU and his contractors and engineers reveal LUIS RIU's continued reliance on FERNANDEZ's influence as Miami Beach Building Director.

Your Affiants can confirm that FERNANDEZ approved the "Building Final" section under sub permit B1500960 on January 28, 2015. On the same date, FERNANDEZ also approved the "Structural section" of sub permit BREV150353 and "Elevator approval" section of sub permit BP150016. Your Affiants have probable cause to believe these sub permit approvals by FERNANDEZ are the final approvals which would allow the Riu Miami Beach to open, as indicated in Sanchis's emails to LUIS RIU above, and are within FERNANDEZ's control as Building Director. As of January 30, 2015, the Riu Miami Beach could not reopen until Fire approved the inspection of the fire alarm system.

Your Affiants have probable cause to believe the inspections LUIS RIU is indicating he wants FERNANDEZ to speak with "Virgilio" (Fire Chief Virgilio Fernandez) and fix the inspections conducted by Bacallao on February 2, 2015 and the pending Fire inspections. LUIS RIU also contemplates paying more or bribing Miranda to have the fire inspections completed. Although Miranda is a private engineer employed by the RIU, the above email communication indicates LUIS RIU is willing to do what he believes is necessary to reopen the Riu Miami Beach.

The Temporary Certificate of Occupancy ("TCO"), which would allow the Riu Miami Beach to reopen for guests, was issued on February 11, 2015. Your Affiants reviewed the inspection history for the Riu Miami Beach and found that in the month leading up to the TCO (January 15 – February 11), FERNANDEZ performed thirty-four inspections<sup>1</sup>. For each of the inspections, which involved the master permit and eighteen sub-permits, FERNANDEZ gave his approval.

RIU employees discussed FERNANDEZ's assistance and promises among themselves in emails, which are pasted below. Your Affiants discovered that on February 4, 2015, LUQUE optimistically told CEO Pepe MORENO that, according to FERNANDEZ, the inspection process should be almost over.

Your Affiants examined the Riu Miami Beach's inspection history and spoke to Fire Inspector Joseph Bacallao. Mr. Bacallao testified that he was involved in some of the final

Mr. Bacallao testified that he conducted an additional inspection on February 12th, and determined that one of items was still incomplete, the smoke control system. Mr. Bacallao also testified that he remembered FERNANDEZ acting as a go-between for the RIU and the Fire Department, advocating for inspection approval. On the date FERNANDEZ approved the TCO (February 11, 2015), Fire had not given final approval of the Fire Alarm system at the Riu Miami Beach.

Building Department Trip to Riu Resorts in Punta Cana and Playa del Carmen

Immediately after FERNANDEZ allowed for the Riu Miami Beach to reopen, the RIU offered FERNANDEZ a special rate for his entire department to stay at the Riu Palace Bavaro all-inclusive resort, in Punta Cana, Dominican Republic. Your Affiants have received differing accounts regarding who first suggested that the Building Department stay at a RIU hotel. According to LUQUE, FERNANDEZ reached out to one of the RIU's engineers to enquire about the Building Department employees going to a RIU resort in the Caribbean. LUQUE testified:

When we were reopen it again, one of the engineers told me, look, some days ago. Mr. Mariano Fernandez call me to ask me, hey, who is responsible for the resort in the Caribbean? We make every year a team building trip, and we want to receive a quotation from your resorts. Perhaps it's possible to go there, or something like that. And he told me could you contact him? And I contact Mariano Fernandez.

Conversely, according to FERNANDEZ, the RIU approached him with the idea. FERNANDEZ told SAPCTF investigators: "the RIU came to us and said, 'Guys—even though we paid double fees, you guys were so great, and we finished on time what we were

Your Affiants learned that before finalizing the offer to FERNANDEZ, RIU executives and employees discussed whether they should charge FERNANDEZ at all. Your Affiants discovered email communications between LUQUE, MORENO, LUIS RIU, SANCHEZ, and RIU employees in Punta Cana regarding the trip for FERNANDEZ and his department. These emails were sent on February 11<sup>th</sup> and 12<sup>th</sup>, 2015—the day of and the day after FERNANDEZ took action as Building Official and allowed the Riu Miami Beach to reopen. Some of these emails are pasted below.

Your Affiants have probable cause to believe that through these emails LUQUE, LUIS RIU, MORENO, and SANCHEZ used and conspired to use the RIU to reward FERNANDEZ for FERNANDEZ's official actions as Building Official.

FERNANDEZ told SAPCTF investigators that he refused the RIU's offer of a free trip for his department:

And I told him, "I'm sorry, I cannot accept that," you know, "What? You want to get me fired?" Or something like that, you know, that's unacceptable to me. So, he said, "Well, I'll give you a price of friends and family. . . . And you can take the whole crew, whatever you want."

LUQUE testified that the RIU eventually offered FERNANDEZ a rate of twenty-five dollars (\$25) per person, per night, for four (4) nights at the Riu Palace Bavaro. LUQUE testified that he assisted FERNANDEZ and the other people from the Building Department who FERNANDEZ had assigned to coordinate the trip to Punta Cana. LUQUE arranged for transportation and helped FERNANDEZ find a cheap airline for the flight to Punta Cana. LUQUE was able to arrange for round-trip tickets on Spirit Airline from Fort Lauderdale International Airport to Santo Domingo. LUQUE also arranged for a bus to drive everyone to and from the airport and the RIU resort. The total expense for the trip was advertised at \$449 per person. LUQUE designed a flyer for the Building Department to advertise the trip, which is pasted below on the following page:



Your Affiants learned that FERNANDEZ assigned two office associates—Sandra Meyer and Karla Santana—the task of coordinating the Punta Cana trip. Your Affiants retrieved an email from Ms. Santana to Ms. Meyer, in which Ms. Santana had memorialized the publicly advertised price for four nights at the Riu Palace Bavaro (subject: "if you buy it on your own"):



This email from Ms. Santana to Ms. Meyer was sent on April 10, 2015, the same day that both of them stayed at the Riu Miami Beach—Ms. Meyer received two nights for free and Ms. Santana received two nights at a significantly reduced rate (discussed below).

According to records Your Affiants received from the RIU, 102 Building Department employees and their family members participated in the Building Department trip to the RIU resort in Punta Cana.

Your Affiants discovered that in 2016, the RIU offered the building department a similar deal for another team building trip to the Riu Palace Mexico all-inclusive resort in Playa del Carmen. According to RIU records, eighty-nine people participated in the trip. The cost was \$36 per person, per night. The Building Department's trip to Riu Palace Mexico trip is detailed below (pages 90-99).

Your Affiants learned that FERNANDEZ was able to solicit one free room and one heavily reduced room at the Riu Miami Beach for two of his office associates—Sandra Meyer and Karla Santana. Your Affiants learned from the RIU's records that Ms. Meyer received one room for two nights for free. Ms. Santana received the other room for two nights for \$125/night, which was approximately a 70% discount over the standard rate.


According to LUQUE, FERNANDEZ approached him on April 9<sup>th</sup> or 10<sup>th</sup>, 2015, to ask about special rates for two of his employees for that weekend (April 10, 2015 was a Friday). LUQUE testified that he told FERNANDEZ he would check and get back to him. LUQUE testified that he called FERNANDEZ a short time later and said that he could give FERNANDEZ one complimentary room and one discounted room, which FERNANDEZ accepted.

Your Affiants learned that after speaking with FERNANDEZ, LUQUE emailed Manuel Donoso, the Director of Sales for the Riu Miami Beach. LUQUE is Mr. Donoso's direct supervisor. In the first email, LUQUE tells Mr. Donoso to make a reservation in the name of Sandy Meyer. The reservation should be for one free room with breakfast and one room with breakfast for \$125 + tax. 

Your Affiants learned from LUQUE and other RIU employees that the Riu Miami Beach has three classes of rooms: City, Vista Mar, and Mar Frontal. The City rooms are the cheapest; they face West towards Collins Ave. Vista Mar rooms are the middle-tier; they have at least a partial ocean view. Mar Frontal rooms are the most expensive; they face the ocean.

Your Affiants obtained records from the RIU that confirm these stays took place as planned. Your Affiants obtained invoices, which the RIU refers to as "folios." The first folio (page 34) indicates that Sandra Meyer stayed in room 904 from April 10, 2015, until April 12, 2015 (two nights). Mr. Donoso testified that room 904 is an Ocean Front room, which is the most expensive type of room at the Riu Miami Beach. Mr. Donoso testified that although the email he sent to LUQUE indicated that Sandra Meyer would receive an ocean view room, she was upgraded to an ocean front room. The "HD" indicates that breakfast is included in the reservation (Your Affiants have probable cause to believe that "HD" stands for "habitacion y desayuno," which means "room and breakfast"). The only item charged under this reservation is valet parking, which was \$59.92 for the entire stay. Ms. Meyer confirmed that she stayed at the RIU that weekend.


The second folio (page 35), indicates that two adults stayed in room 908 from April 10, 2015, until April 12, 2015 (two nights), with breakfast included. Mr. Donoso testified that room 908 is also an Ocean Front room, and that the same upgrade occurred for this reservation. The advertised rate for room 908 was \$399 per night, but the RIU only charged \$129, which was apr 71.44% discount. Although this reservation was under the name Sandra Meyer, receipts provided by the RIU indicate that the reduced rate was paid by Karla Santana and Karla da Silva. Ms. Santana testified that she stayed in the room with her friend Karla da Silva.

LUQUE testified that he offered these rooms to FERNANDEZ on behalf of the RIU in appreciation for FERNANDEZ driving the RIU in the right direction during the renovation process. Your Affiants have probable cause to believe that the RIU and LUQUE offered these benefits as a reward for FERNANDEZ's official actions as the Miami Beach Building Director for the RIU. Based on FERNANDEZ's statement to SAPCTF investigators, Your Affiants have probable cause to believe that FERNANDEZ knew, when he accepted these unlawful benefits on behalf of Ms. Meyer and Ms. Santana, that the benefits were being offered because of the official actions FERNANDEZ had taken as the Miami Beach Building Director for the RIU.

Ms. Dooley testified that she told FERNANDEZ that she was looking for a hotel, to which he responded "Oh, you should stay at Riu, I can get you over there."

LUQUE did not remember the exact conversation he had with FERNANDEZ about a room for Ms. Dooley, but LUQUE testified that each time FERNANDEZ requested a room, FERNANDEZ would call either the same day or the day before. For Ms. Dooley, the reservation process was similar to the previous one for Ms. Meyer and Ms. Santana. Your Affiants also have probable cause to believe that the RIU and LUQUE offered these benefits as a reward for FERNANDEZ's official actions as the Miami Beach Building Official for the RIU.

#### Free room at the Riu Miami Beach for Iliana Oliva

Your Affiants learned that FERNANDEZ solicited a free weekend at the RIU Miami Beach for Iliana Oliva, FERNANDEZ's former coworker who works for the City of Miami Building Department. Your Affiants learned that Iliana Oliva stayed with her family at the Riu Miami Beach from July 31, 2015, until August 2, 2015.

Ms. Oliva provided your affiants with sworn testimony. Ms. Oliva testified that she reached out to FERNANDEZ for advice because she was looking to spend a weekend with her family at a hotel in Miami Beach. At the time, Ms. Oliva's family was dealing with a serious medical hardship. Ms. Oliva testified that FERNANDEZ told her that she should stay at the Riu Miami Beach. FERNANDEZ told Ms. Oliva that he had stayed at the hotel before, that it was nice, and that it had a good breakfast buffet. Ms. Oliva testified that she tried to book a room using Expedia.com for five people, but could not because the official maximum occupancy for a room at the Riu Miami Beach is four. When she told this to FERNANDEZ, he responded, "that shouldn't be a problem," and that he would handle it. Ms. Oliva testified that FERNANDEZ later assured her that he had made the reservation and that they would let her have five people in the room. Ms. Oliva testified that she spent a weekend at the Riu Miami Beach with her husband, her two children, and her mother. Ms. Oliva testified that when she went to check out, the front desk told her that she did not owe anything. Ms. Oliva and her husband tried to pay for their stay, but the person at the front desk said that the room was paid off. Ms. Oliva testified that she believed FERNANDEZ had paid for her stay.

Ms. Oliva testified that after she left the Riu Miami Beach, she called FERNANDEZ. She asked why he had paid for their room and told him that she did not want him (FERNANDEZ) to pay for their room. Ms. Oliva provided the following summary of FERNANDEZ's responses to her:

"The reason I did that for you is because I feel so bad for what's happening to your family... and I wanted to do something nice for you and your family because your family is beautiful." Ms. Oliva testified that she offered to pay FERNANDEZ back, to which he replied, "No. No, you are a very nice person. You are having a very hard time. I want to do something for your family."

Ms. Oliva testified that based on FERNANDEZ's words, she believed that FERNANDEZ had paid for her room. FERNANDEZ did not correct her. Ms. Oliva testified that up until she met with Your Affiants, she believed that FERNANDEZ had paid for her stay. When she learned that the stay was free, she asked Your Affiants if there was any way she could pay.

Your Affiants recovered the emails that discussed setting up Ms. Oliva's free stay. Although LUQUE did not independently recall the conversation with FERNANDEZ about Ms. Oliva's stay, the circumstances give Your Affiants probable cause to believe that FERNANDEZ and LUQUE spoke about reserving a room for Ms. Oliva. LUQUE sent an email to Mr. Donoso telling him to make a reservation for Iliana Oliva from July 31<sup>st</sup> to August 2<sup>nd</sup>, for two adults and two kids, and with breakfast included. At the end of the email, LUQUE wrote "Solicitud Building Departmen" (unofficial translation: "request building department"). Mr. Donoso responded to LUQUE with a confirmation code, and LUQUE forwarded the exchange to FERNANDEZ. The email exchange between Mr. Donoso and LUQUE is pasted below:
