ROCKXANNE SAID WHEN PAULO ARRIVED WITH TYLER, SHE SAW TYLER WAS NOT SITTING IN A CAR SEAT AND AN ARGUMENT FOLLOWED. SHE SAID PAULO DROPPED OFF TYLER AND LEFT THE SCENE. WHILE SPEAKING WITH ROCKXANNE, PAULO RETURNED TO ROCKXANNE'S HOUSE. HE KNOCKED ON THE DOOR AND OPEN THE MAIN DOOR BY HIMSELF WITHOUT BEING GIVEN PERMISSION. ROCKXANNE SAID PAULO HAS THAT BEHAVIOR AND WOULD LIKED HIM TRESPASSED FROM HER PROPERTY.

I SPOKE WITH PAULO WHO SAID TYLER HAD A CHILD BOOSTER TYPE OF SEAT AND SHOWED IT TO ME IN HIS VEHICLE. I EXPLAINED TO PAULO HE WAS TRESPASSED FROM THE PROPERTY FOR A PERIOD OF ONE YEAR AND HE UNDERSTOOD. THEY BOTH STATED THEY WOULD COMMUNICATE WITH EACH OTHER TO ARRANGE ANOTHER DROP OFF AND PICK UP LOCATION FOR THE CHILD. AT THIS TIME, IT WAS DETERMINE NO CRIME HAD BEEN COMMITTED. AN FIELD INTERVIEW REPORT (FIR) DOCUMENTING THE TRESPASS WAS COMPLETED.
