Before me this date personally appeared RUTKOWSKI, ROBERT (9723) who being first duly sworn deposes and says that on 19 day of March, (year) 2018 at 5901 PINE ISLAND RD, PARKLAND, FL 33076 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

On March 19, 2018 at 1630hrs, the defendant Zachary Cruz, unlawfully entered the school grounds of Stoneman Douglas High School and committed the crime of trespassing on school grounds after prior warnings by school officials to refrain from entering the school campus. Defendant Cruz surpassed all locked doors and gates and proceeded to ride his skateboard through school grounds. Defendant Cruz stated that he unlawfully entered the school property to "Reflect on the school shooting and to soak it in" referring to




