### EMERGENCY ORDER GRANTING TEMPORARY CUSTODY

This cause came before the Court on a Petition for Legal Custody of a Minor Children filed by the children's grandmothers, Betty L. Osceola and DeeDee Kelly on March 16, 2018. This Court has jurisdiction pursuant to Title IX ("Juveniles") of the Miccosukee Law and Order Code, as well as the unwritten customs and traditions of the Miccosukee Tribe and its constituent Clans. After a review of case file and the Petition, this Court **FINDS** that:

- 1. The Petition demonstrates probable cause that these children come within the juvenile jurisdiction of this Court.
- 2. **ANNA MAE KELLY** and **CHRISTIAN KELLY** are enrolled members of the Miccosukee Tribe of Indians of Florida. The mother of **RONAN INGRID LARKINS-JOHNSON** is an enrolled member of the Miccosukee Tribe of Indians of Florida.
- 3. After hearing on November 15<sup>th</sup>, 2017, this Court entered an Injunction for Protection for the minor children's mother and **ANNA MAE KELLY** in which **JUSTIN JOHNSON** admitted, by virtue of his inexcusable default after proper notice, to his commission of an incident of violence against the mother during the pendency of her pregnancy with **RONAN INGRID LARKINS-JOHNSON**. There is otherwise reasonable cause to believe that such incident did occur.
- 4. It is in the best interests of the children that they remain temporarily in the joint physical and legal custody of their maternal grandmothers, **BETTY OSCEOLA** and **DEEDEE KELLY**.

IT IS THEREFORE ORDERED AND ADJUDGED that:

- 5. **BETTY OSCEOLA** and **DEEDEE KELLY** shall immediately exercise joint physical and legal custody of the minor children, **ANNA MAE KELLY** and **CHRISTIAN KELLY**, until a hearing is held on this matter. They shall be entitled to medical and school records of the children, and to make decisions regarding healthcare, education, and religious upbringing during this time.
- 6. BETTY OSCEOLA shall immediately exercise joint physical and legal custody of the minor child, RONAN INGRID LARKINS-JOHNSON, until a hearing is held on this matter. She shall be entitled to medical records of the child, and to make decisions regarding healthcare, education, and religious upbringing during this time.
- 7. The minor children's mother, **REBECCA KELLI SANDERS**, shall be entitled to supervised visitation with the children during this period. During these visits, Miccosukee Social Services will provide supervision. The length and conditions of such visits shall be determined by the maternal grandparents in consultation with Miccosukee Social Services.
- 8. The father of **RONAN INGRID LARKINS-JOHNSON**, **JUSTIN JOHNSON**, shall not have unsupervised contact with the minor child until a hearing is held on this matter. During any visits, Miccosukee Social Services, or any child protective services agency approved by the Tribe, will provide supervision. The length and conditions of such visits shall be determined by the maternal grandparents in consultation with Miccosukee Social Services.
- 9. After investigation, Miccosukee Social Services shall provide the Court with a Report and Recommendation regarding the continuing propriety of this placement. If continued placement is recommended, Miccosukee Social Services shall file a proposed Case Plan to the Court, after consultation with the children's clan.
- 10. Any law enforcement officer designated for this purpose with the consent of the Tribe shall have the right to enforce this Order pursuant to 18 U.S.C. Sections 2265 and 2266. This is an order for Child Pickup pursuant to those statutes.
- 11. The Court will schedule a hearing on this matter within a reasonable time. The parents will be given reasonable notice and the opportunity to be heard
- 12. This Court shall retain jurisdiction for any and all issues related to this matter.
