DEFENDANT COUNSEL'S MOTION TO WITHDRAW

Comes Now Undersigned Counsel, files this Motion to Withdraw. As grounds thereof the following is set forth:

1. The Defendant was Indicted on September 7, 2018 and charged with Five(5) Counts of Wire Fraud, pursuant to 18 USC § 1343, and Two(2) Counts of Money Laundering, pursuant to 18 USC § 1957.
2. The Defendant entered a plea of guilty on February 14, 2019 to Five (5) Counts of Wire Fraud and the Two Counts of Money Laundering were going to be dismissed at Sentencing.
3. The Court set a Sentencing Hearing for May 29, 2019.
4. Undersigned Counsel had an office conference scheduled with the Defendant for May 28, 2019, to finish preparing for the sentencing.
5. However, on May 23rd, 2019, the Defendant notified our office in writing that he is requesting that we file a Motion to Withdraw as Counsel from his case.

6. That due to the Defendant's refusal to cooperate with our office in the preparation of his sentencing the Attorney-Client relationship is irretrievably broken.
7. Undersigned Counsel will not be prepared to go forward at the sentencing hearing without the cooperation of her client.
8. The Assistant United States Attorney, Lisa Miller, does not object to this Motion.

WHEREFORE, based upon the foregoing, Undersigned Counsel requests to be withdrawn from his case.
