PRE-TRIAL AGREEMENT / STIPULATION FOR DEFERRED PROSECUTION
RE: NOTICE TO APPEAR / UNIFORM TRAFFIC CITATION / INFORMATION

This matter comes before the Court upon stipulation between the State of Florida and the defendant to redirect this case into an alternative resolution/diversion program.

It is agreed that if all conditions are successfully completed in a timely manner and the defendant has not been arrested for new charges, has not received any additional Notices to Appear or Uniform Traffic Citations, has not been convicted of any new crimes, and does not fail to appear, the State will abandon prosecution of this case.
3. Extensions of this agreement may be granted upon the discretion of the prosecutor.
