
The Defendant was charged with Aggravated Assault with a Deadly Weapon (box cutter), Domestic Battery by Strangulation and Battery.

The victim, _____ was married to the D. The D had been drinking alcohol all night and was intoxicated. The D allegedly returned home, entered the bedroom and jumped on the victim wrapping his hands around her throat. The D punched her multiple times in the lip causing visible bruising. The D produced a box cutter and threaten to kill her with it. The D climbed off of her and told her to get out of the apartment. The D fled the apartment and got in her vehicle and called the police.


I spoke to the victim many times in reference to this case. While cooperative, she was extremely anxious about giving a deposition and the possibility of a jury trial. She wanted me to resolve the case to probation so that there would be some consequences and so that the D would not bother her any\ more. She stated that the basis of the problem was the D's alcohol binges.

Based on the above and the lack of any serious criminal record and the fact that the D had done 272 days in the Broward County Jail I offered the following plea:

Ct. 1 Agg Assault: nolle prossed
Ct. 2: Strangulation
2 years probation
BIP
Substance/alcohol evaluation and treatment
\$600 restitution
No contact
Ct. 3 Battery
12 months prob concurrent (minus the 272 days credit)

NOLLE PROSSE MEMORANDUM

The D was charged with one count of Felony Battery by Strangulation.

This case was nolle prossed due to a lack of victim cooperation. All attempts by the undersigned to convince the V to come forward, cooperate, and testify in this matter were unsuccessful.

I could not obtain a call back from the V. The praecipe from the first trial date indicated that the V was served and that therefore the address was correct.


In an abundance of caution I did an investigative request for the trial date of 5-3-11. Inv. Diaz verified that the V's address was correct. The V did not call me nor show up for trial.

There were no independent witnesses.

The undersigned having reviewed the facts of the case was unable to proceed without essential witnesses and there being no reasonable likelihood of conviction was compelled to announce a nolle prosse.
